Membership Application and Agreement

WE HEREBY Declare that we are exercising our right to freely associate keeping all ministry and business in the private domain. Our Private Membership Association (PMA) activities are restricted to the private domain only.

The Holy scriptures, the Universal Declaration of Human Rights, the Constitution of the United States, and the various constitutions of the several states of the union guarantee our Members the rights of absolute freedom of religion, free speech, petition, assembly, freedom from unreasonable search and seizure, the right to not incriminate ourselves and the right to freely exercise all other unalienable rights as granted by our Creator.

BY MAKING CONTRACT with and/or using the website and/or social media and/or attending activities sponsored by the PMA and its programs, I am agreeing to the terms of membership for Hutchinson Healing Ministries.

Terms and Conditions

- 1. This Association of Members declares that our objective is to provide the Private Membership Association Founders and Members with a platform in which to conduct all manner of private ministry and business.
- 2. We declare the basic right of all our Members to decide for themselves which Association Members could be expected to give wise counsel, tips, advice and assistance concerning all matters including, but not limited to physical, spiritual, mental and relational health care and Natural Law.
- 3. We expect the freedom to choose our own spiritual life journey; the freedom to choose and perform for ourselves the types of therapies and treatments that we think best for diagnosing, treating and preventing illness and disease and for achieving and maintaining optimum wellness; the freedom to choose for ourselves any types of assistance which may be made regarding law and any other private business activity; the freedom to educate our children the way we think is best; the freedom to grow and eat healthy foods.
- 4. The PMA will recognize any person, natural or otherwise (irrespective of race, color, or religion) who has joined this PMA or any social media group organized, created, or managed by this PMA and is in agreement with these principles and policies as a

member of this PMA, providing said person has not been sanctioned, removed, or otherwise banned by the PMA. The PMA will provide a forum through which its individual members may associate to actuate and bring to fruition the purposes heretofore declared.

- 5. Membership to Hutchinson Healing Ministries and any of its Programs or Groups may be terminated by the PMA Trustees or their designee, at any time, due to failure to adhere to the Code of Conduct listed below.
- 6. This PMA is outside the jurisdiction and authority of Local, County, State, and Federal Agencies and Authorities concerning licenses, permits, policy and any complaints or grievances against PMA members.
- 7. Being outside the jurisdiction of Local, County, State or Federal Agencies, conflict, complaints or grievances will be settled through the Conflict Resolution Process outlined by the PMA.
- 8. This PMA establishes a Covenant of Silence between the Holder of Office and the individual Members that requires that personal and private information be kept confidential. The Covenant of Silence does NOT apply when Natural Law has been broken¹.

Code of Conduct

- 1. I agree to observe Natural Law.
- 2. I agree to keep my word, not encroach on others or their property, to hold to good character, to high morals, to live with conviction, and to perform my duties (if any), responsibilities, and calling with diligence and commitment.
- 3. I agree not to engage in abusive, violent, manipulative, controlling, menacing, destructive or harassing behavior.
- 4. I agree to communicate with patience, compassion and transparency in all cases: face-to-face, online, spoken word and written word.
- 5. I agree to show a high level of respect, appreciation and acknowledgement for all peoples' efforts, perspectives and opinions.

¹Natural Law states that we do no harm and take nothing we do not have the right to take. It prohibits murder, rape, assault, theft, trespass, coercion and deception.

Statement of Participation

- 1. I voluntarily agree to join Hutchinson Healing Ministries, a Private Membership Association, governed by the Creator's Natural Law as interpreted by Hutchinson Healing Ministries, whose members seek to love each other, heal and restore.
- 2. I inner-stand² that my capacity in this PMA is that of a private member (as opposed to a public person).
- 3. I enter into this agreement of my own free will without any pressure or coercion and my questions have been answered fully to my satisfaction.
- 4. I inner-stand that I can withdraw from this agreement and terminate my membership in this PMA at any time, and that my membership can and will be revoked if I break the Code of Conduct above, inside or outside the PMA.
- 5. I fully agree that all conflicts are to be resolved internally within this PMA through the Conflict Resolution process and agree not to pursue recourse outside of the PMA unless a Member has forced me into a situation of a clear and present danger of substantive evil, and upon the recommendation and approval of the Association.
- 6. I will not share my activities within the PMA, which are a private contractual matter, with the Local, County, State, or Federal investigative or enforcement agencies.
- 7. I affirm that I am here in my private capacity and do not represent any Local, County, State or Federal agency whose purpose is to regulate and approve products or services, or to carry out any mission of enforcement, entrapment or investigation.
- 8. These pages consist of the entire agreement for my membership in the Association.
- 9. I am agreeing to a private contractual agreement with Hutchinson Healing Ministries, a Private Membership Association, beginning on the date written below.
- 10. I declare that by joining this PMA and/or the PMA's website(s) and/or social media group(s), I have carefully read the whole of this document, my questions have been answered fully to my satisfaction and I comprehend and agree with it.
